Sealed Bids for the construction of the **Crystal Lake Drive Interceptor Improvements Project** will be received at the Board Room of the Administrative Building (Station R) at the Urbana and Champaign Sanitary District, located on 1100 E. University Avenue, Urbana Illinois 61802 until **2:00 p.m., Local Time on the 12th day of February 2026**, at which time the Bids received will be opened and read aloud. The Project consists of constructing:

The Work of this Contract is generally described as a sanitary sewer installation project that includes the following:

1. Supplying labor, equipment, and materials necessary to provide approx. 135 LF of 42-inch diameter sanitary sewer and two sanitary manholes. The Work also includes site work, seeding, paving, and other services and items of construction.
2. Maintaining flow in existing sewers by flumes, chases, bypass pumping or other means.
3. Providing dewatering services as required.
4. Providing traffic control for public and access for Contractor's equipment.
5. Obtaining all permits for construction of Work not obtained by Engineer or Owner.
6. Removing all debris and excess materials from Project Site generated by construction work.
7. Restoring areas disturbed by construction to original condition or as specified by Contract Documents.

BID REJECTION/ACCEPTANCE: The Owner reserves the right to reject any and all Bids, waive informalities in bidding, or to accept the Bid or Bids, which best serves the interests of the Owner.

BID WITHDRAWAL: No Bid shall be withdrawn for a period of **60** days after the scheduled opening of the bids without the consent of Owner.
